Our Speaker his month is JAMES CALASKI

James completed his undergraduate studies at William Paterson University of New Jersey in January 1998, receiving a Bachelor of Arts degree in Sociology with a concentration in Criminal Justice. While attending WPU, he worked full time as a private investigator under a former US Secret Service Agent. Following his undergraduate studies, he pursued a career in law enforcement and joined the Glen Rock New Jersey Police Department in February 2000. Prior to this appointment, James served with the Glen Rock Auxiliary Police for two years. He subsequently served eight years in the Patrol Division, before being appointed to the Detective Bureau. In November 2017 James was promoted to Detective Sergeant and currently serves as the Bureau supervisor.

He continued his education and received a Master of Arts degree in History from William Paterson University of New Jersey in May 2013. While researching his thesis topic, the German American Bund, he came across documents regarding a resident of Glen Rock named Schiphorst. Schiphorst resided in Glen Rock during the 1930's and was a leader of the Bergen County Unit of the Bund as well as the target of a 145 page FBI investigation suspecting Schiphorst of being a Nazi agent. For the past several years, he has continued to study Carl Schiphorst, the FBI investigation, his internment, and ultimate repatriation to Germany, a story which illustrates the plight of thousands of German families during WWII.

#### The Book Club

The First Conspiracy: the secret plot to kill George Washington, by Brad Meltzer and Josh Mensch, was our first book to be discussed and was summarized by Vince Tortorelli. It focuses on the American Revolutionary War but rather on specific battles it tells the story of those loyal to the Crown who in the spring and summer of 1776 were spies and agents working to aid the British to undermine the American war effort and its leader George Washington. Chief among those loyalists was William Tryon, New York's colonial governor and David Matthews, the NYC mayor. The book briefly traces Washington's early life to set the stage for his ultimate leadership in the War effort and demonstrates his critical role in turning a ragtag group of various state militias into a fighting army. As the conspiracies grew a counter-intelligence group headed by John Jay, who ultimately became Chief Justice, was formed that was effective enough to help force Tryon to abandon his mansion in NYC and seek refuge on a British Warship in the harbor. This group many believe was the forerunner of the CIA. Washington also formed an elite group, the Life Guards, to surround him but some were indeed closet Loyalists, including Thomas Hickey who was charged with treason and ordered to be hanged by Washington in a public square. While spiced with much intrigue and clearly positioning Washington as the key to the success of the war, the authors provide little hard evidence of a specific plot to assassinate the general.

Next up was *The Vanishing American Adult* by Ben Sasse, reviewed by John Galvin. In it the author describes the causes of a generation that can't seem to grow up, citing too many parents who do not adequately prepare their children for challenges they will face as they grow older, leading to too many youngsters who are passive, insular, coddled and lacking a strong work effort. He doesn't look for answers from schools and understands there are outside factors like broken homes, etc. but Sasse outlines programs he considers important for youngsters to grow, including much less screen time, more reading, travel – in essence more guidance and understanding the difference between want and need. A lively discussion followed with some lines drawn between whether the solutions proposed were more largely applicable to the more affluent and educated and whether the author painted with too large a brush since there many examples in today's young generation of productive and well balanced individuals. A provocative session.

**ONE IMPORTANT NOTE:** Since December's regularly scheduled date for our meeting this year falls on Christmas Day we are cancelling our meeting for December. With the busy holidays and other activities and venues already on the calendar it is deemed too complicated to fit it in. Therefore books originally scheduled for December will be covered in January and January's books in February.

The Fortunate Pilgrim by Mario Puzo. Puzo's personal favorite, the life of a southern Italian immigrant who settled in NYC in the 1920's. (Fiction)

Books for February:

Infamy by Richard Reeves

A description of the internment of the Japanese in America in evacuation centers and camps during World War II and the reactions of American Japanese. (Non-fiction)

In the Wake of the Plague by Norman Center

A look at the Black Death in 14<sup>th</sup> century Europe and its effects (Non-fiction)



# **Public Discussion Group**

The November meeting departed from the usual format in order to host a presentation on the various options available to Medicare participants during the current enrollment period. Two representatives of NJ Life and Health Insurance Group, an insurance brokerage agency located in Tom's River, (www.njlifeandhealth.com) provided a very detailed description of choices that Medicare members might consider. As brokers, the agency receives its fees from insurance companies and not from the insured. As such, maintaining existing or new clients is key to their business and they advised that it was in their interest to ensure clients understood all the "pluses and minuses" of each option. This firm had made a presentation to the membership a few years ago and members felt it was very helpful. The firm has already committed to make a presentation to the AU membership in 2020 prior to the enrollment period so members can consider the best options respectively. A detailed explanation of Basic Medicare (Parts A & B), Medicare Supplement plans, and Medicare Advantage plans was given. One point that was emphasized was that participants should carefully review any plans purchased on an annual basis as conditions, such as prescriptions, participating doctors and costs can, and often do, change year to year. This was a very informative, informational presentation and Discussion Club members seemed to find it helpful.

The next meeting is on Wednesday, December 11<sup>th</sup> at 9:30 a.m. at Larkin House, 380 Godwin Avenue. The topic post-poned from the November meeting, "the Electoral College," will be taken up. Other topics may be suggested from the floor at the start of the meeting. All members are welcome to attend and just listen or join in.

# The Computer Technology Club

There were 28+ AU Members in attendance at the Wednesday, November 20, 2019 meeting of the Computer Technology Club. The meeting topics included a variety of items with the focus of the meeting being a look at Artificial Intelligence in general and how the medical industry is starting to use it in diagnostics and for patient visits via smart phones. Prior to our normal look at several technology-oriented videos and gadgets we watched a comedy-oriented video using an Apple iPad. And a look at how world religions have changed over the past 50+ years through a statistical app that plotted numbers of individuals by specific religions. The first was a look at a video on **Smart Beam** ... this is a product that is a small cube (4.5" by 4.5") that projects images from your smart phone. Next, we watched two interesting videos relating to bike safety ... the first was **Lane Sight** and the second was called **Smart Halo**.

Then we looked at several items included on the AU's website, new items added to the Computer Page Reference section and/or to the Helpful Tips section. We also, explored several other sections of the AU Website to let those in attendance know what is out on the AU Website ... specifically we looked at the Science Club Page where we will be posting the monthly presentations. This will include backloading some of the past presentations ... all should take a look at this section in the future as the presentation are fascinating.

Next, we discussed a future endeavor the providing of Basic Computer Skills to those AU Members that need some additional hand holding to feel comfortable working with computers. For those individuals that would like to participate please send me an email as to what specific items that you would need help with and that you would like to participate in this initial planning meeting. The planning meeting will be held directly after the regular CTC meeting on Wednesday, December 18th at 11:30AM ... the meeting will last approximately 1 hour. Please remember that this meeting is for only those individuals requiring basic computer assistance (we are limiting this session to 10 individuals). Then we looked at several videos on Artificial Intelligence ... 5 Practical, real world examples of Artificial Intelligence, How AI will change your world in 2019, for better or worse. Next, we briefly looked at and discussed 7 AI Powered doctor phone apps could be the future of healthcare. These videos will be posted to the AU Website computer reference page for future viewing.

The "Ask John" segment was covered by John Abrahamsen. John covered several items; 1) How to declare which app is launched based on file type and 2) how to sizable apps that start when Windows 10 does ... Write-ups on these items will be posted to the website. Also, John led a lengthy discussion on his Ring setup at his home.

#### The Science Club

Dr. Cauchard is an eye doctor in Wyckoff, who has spoken to us previously on conditions of the eye. He invited us to his office to show us his Computerized Camera equipment used for diagnosis, and the November Meeting was held in his Reception Area - seventeen members attended. He gave an excellent talk on the anatomy of the eye, and answered many questions on our eye health and treatment- thank you Dr. Cauchard.

At the Tuesday 10 AM, December 17 meeting, Murray Perl will speak to us on 'Evolution beyond Darwin' -it has been over 150 years since the original theory was proposed. Murray points out that 'Public health, disease control and agricultural technology are directly related to our understanding of modern evolutionary theory and population genetics'. He discusses how pandemics (1918 influenza) which can kill 50 million people, can disappear, while diseases like sickle-cell anemia, cystic fibrosis, Tay-Saks, and PKU can still persist. Also the antibiotics treatments of bacteria we thought we could use for control, are becoming less effective.

Kurt Coster will speak at the January Meeting on Paper Manufacturing.

# **The History Club**



The topic for the November History Club meeting was "The Tuskegee Study of Untreated Syphilis in African-American male, 1932-1972." The speaker was Fred Steinberg. The narrative started with the first recorded European outbreak what is now known as Syphilis, occurred in 1495 among French troops besieging Naples. In 1905, the microbe for syphilis was discovered and that the disease was sexually transmitted. The first effective treatment was Salvarsan, first used in 1908. Later, mercury and bismuth were added to the treatment. These heavy metals were associated with severe and terrible side effects. The Tuskegee Study was conducted during the Jim Crow era. In 1932, the United States Public Health Service, working with the Tuskegee Institute, began a study to record the natural history of syphilis in hopes of justifying treatment programs for blacks. The study was conducted in Macon County, Alabama and consisted of 399 men with syphilis and 201 without syphilis. The researchers told the men they were being treated for "bad blood." In exchange for taking part in the study, the men received free medical examinations, free meals and burial insurance. White and black physicians were involved in the study and the nurse supervisor was black as well. Medical literature recorded what was found but offered no objections. Local physicians asked to assist with the study and not to treat the subjects. In 1969, CDC reaffirms the need for the study and local medical societies and AMA officially support the continuation of the study.

In 1972, first news articles appeared condemning the study and the study ended. In 1973, Congress held hearing and a class-action lawsuit was filed on behalf of the study participants and a \$ 10 million out-of-court settlement was reached. The U.S. government also promised to give lifetime medical benefits and burial services to all living participants. In 1975, wives and offspring's were added to the program. In 1997, President Clinton apologized on behalf of the Nation. In 1999- Tuskegee University National Center for Bioethics in Research and Health Care hosts 1st Annual Commemoration of the Presidential apology.

The Tuskegee Study raised lots of ethical and moral questions- such as patient's informed consent, racism, unfair patient selection in the study, maleficence, deceit and justice among others. The treatment was withheld when in 1945, penicillin was found to cure syphilis. Furthermore, with effective treatment late complications of syphilis such as cardiovascular and neurological involvement could have been prevented.
