

Marty McGonigle led off the December meeting with a review of WONDER GIRL (Don Van Natta), a biography of Babe Didreksen Maharias. This gal excelled in basketball, track and field, softball, tennis and golf. Although she won two gold medals and a silver in the 1932 Olympics she is best known for the numerous amateur and professional golf tournaments she won, including the U.S. and British Women's Open. Babe was diagnosed with cancer in 1954 and died in 1956 at the age of 45. Sports Illustrated listed her as one of the ten top athletes (male and female) of the twentieth century......

BOSS TWEED (Kenneth Ackerman) introduced by **Vince Tortorella**, examined the life of one of the most corrupt politicians in the history of YC. Tweed and his "ring" stole from NYC an amazing estimated \$2 billion (in today's dollars). They were eventually brought down by the investigative reporting of the NY Times, the devastating cartoons of Thomas Nast, and a "whistle blower" who provided the hard evidence of their crimes. Surprisingly, Tweed was the only one sent to jail, where, after a few years, he died in 1878 at the age of 55.....

Joe Pullaro submitted a concise report on TWO AMERICANS -TRUMAN, EISENHOWER, AND A DANGEROUS WORLD (William Lee Miller). This book tells how, after years of relative obscurity, events unfolded in the 1940's, especially WW2 that brought these men into prominence and allowed them to put their stamp on history. Truman's first major decision was dropping two atomic bombs on Japan. Later, faced with Soviet aggression, he was responsible for the Marshall Plan and the Berlin Airlift. Eisenhower brought an end to the Korean War and did an effective join of containing the Soviets and maintaining peace over his eight years in office. The author gives a fair appraisal of their accomplishments and failures, not favoring either side.
