#### The Science Club

The first October meeting was a carpool trip to Lamont-Doherty Labs in Alpine on Saturday, October 7, 2017. Seven members took the trip and enjoyed lectures and demonstrators.

Also on October, the 17 the first of a DVD series called 'Modern Physics for Non-Scientists', course by Professor Richard Wolfson of Middlebury College was shown. This program from the Great Courses Series, reviews the fundamental ideas of physics starting in the year 1900 and leads to relativity and quantum physics. Each of the 24 Lectures is 30 minutes with the first entitled 'Time Travel, Tunneling, and Tennis'. The plan is to use the DVDs at several meetings during the year when other activities are not scheduled. While the lectures build on one another, they will be presented such that continuity is maintained. Response to the DVD was very positive, with members anxious to attend future is DVD presentations.

On Tuesday November 21at 10 AM, DR. Cauchard will return and update us on conditions of the eye. He will explain the operation of the new Digital Camera system which is now being used as part of his testing procedure.

Later in the Fall or Winter we may plan a Carpool trip to either the Liberty Science Center in Jersey City, NJ or the American Museum of Natural History in NYC (which includes the Planetarium-updates on Dark Matter and Dark Energy).

**Public Discussion Group** 

We began by discussion the Gubernatorial debate televised the night before. Only a few members had watched it, but there seemed to be a consensus that the candidates spent most of their time "blasting" the other rather than explaining their policies and vision for NJ's future. Overall a disappointing debate.

he group then turned to the assigned topics. First up was the question of "how to feed the world facing a population of over 10 billion in 30 years." Interestingly, much of the discussion dealt with better, more efficient land use as well as advancing technology. Holland, which achieves the highest production per acre in the world, was brought up as an example of managing the agricultural environment better. Another idea was more use of hydroponic agriculture, which allows multiple harvests per year. Local supermarkets are already carrying salad greens grown in water tanks in New York City. There were no solutions, but some interesting ideas pointing to possible future breakthroughs. On a related topic, we then turned to the issue of "food additives." Discussion focused on the power of large food companies and how through advertising they can influence popular taste. In addition, there is often a revolving door between regulators (FDA and Dept. of Agriculture) and industry with an obvious connection to lobbying. In short, most felt that profits came before public health although there was also some concern about the broader role of government regulation, e.g. efforts to down-size sugary drinks.

Finally, we turned to the challenge of "caring for an aging population." With families often living widely apart because of work and with general mobility and longer life expectancy, the country is entering the opposite end of the "baby boom." And this has given rise to special facilities to care for the aged when they need help or can no longer care for themselves. Of course, the cost is very high and out of reach of the average American. Medical costs of care are sky-rocketing and straining public resources, which raises ethical and medical questions about "end of life care."

As usual, we had no solutions, but enjoyed sharing our views on the topics. For the meeting on November 8<sup>th</sup> (which <u>falls before the general meeting</u>) at Larkin House at 9:30 am our topics will be: Bear and Deer Culling Hunts; Opiate Epidemic; and the Iran Issue. All members are welcome.

This program is provided at various sites (Hawthorne, Wayne, Ringwood, West Milford, Clifton, Paterson, and Passaic) in the Passaic County area. This could not be done without the help of volunteers who make an indelible mark on those communities that they help. You will find the work of assisting people of limited means to be rewarding and fulfilling and deeply appreciated by those who we serve.

There were 30 AU Members in attendance at the Wednesday, October 18, 2017 meeting of the Computer Technology Club. The meeting topics included a variety of items with the focus of the meeting being a look at making a video from your pictures with music.

The meeting kicked off with a look at four very interesting new technology videos, the first was a look at **ASAP Connect** a new type of USB connection that facilitates an easy connection. Next, we viewed a video on **Boncho** a new type of rain gear that covers more than just you. This followed with a video on **Paper Talk** a very thin computer that connects multiple pages IE: computer screen. And, lastly a new use for the **Drone** it is ambulance tool-kit to facilitate the saving of a life through rapid response time.

Then we looked at several items included on the AU's Web-site, new items added to the Computer Page Reference section and to the Helpful Tips section. We also, explored several other sections of the AU Web-Site to let those in attendance know what is out on the AU Web-Site.

Also, we looked at various options to contain one's credit record as the result of the recent breach at Equifax ... one of the three main credit bureaus.

The Book **Club** 

 $\lambda$  t the October 25 Book Club meeting three books were reviewed and discussed:

The City of Thieves, a novel by David Benioff, was summarized by Vince Tortorelli. It is a story that takes place in Leningrad during January 1942, a few months after the start of the German siege of that city that ultimately lasted about 900 days. The 2 main characters are Lev, a 17 year old arrested for robbing a dead German pilot, and Kolya, an adventurous young Russian army deserter, who bargain for their freedom by agreeing to find a dozen eggs for the prison's Commandant, who wanted the eggs for his daughter's wedding cake. The book follows their escapades during their search but also provides a stark picture of what the citizens of the city endured during that brutal time.

*The Life and Times of the Thunderbolt Kid*, by Bill Bryson, was presented by **Frank Schwarz**. It is a lighthearted look back at the 1950's and what the author enjoyed (and endured) as he grew up during that iconic period. The trip down memory lane resonated with the group since it brought back similar experiences to us all.

*The Drone Warrior*, by Brett Velicovich, was recapped by **George Lewis**. Velicovich was an integral part of the Delta force, an elite U.S. military group, and it is (to the extent allowed by classified restriction) an inside look of America's new warfare technology – using unmanned drones (in military parlance Unmanned Aerial Vehicles) to take down or help capture terrorists. As the book follows Velicovich's intense career, it also demonstrates how drones are also effectively used in the civilian sector as the author spent some time in Africa tracking down poachers of endangered animals.

### **Fred Michel**

**Fred Michel** (1926-2017) was a man of faith. If Wyckoff Reformed Church had saints Fred would be one of them. Fred served the Wyckoff Reformed Church as a Sunday School teacher and as an Elder on the church's governing board, the Consistory. He enthusiastically supported the church's food pantry for Northside Paterson. He was also a charter member of Activities Unlimited.

Fred served on several Consistory committees. One of these was a Search Committee for a new Associate Pastor. That is what, 45 years ago, led Fred and his wife, Betty, along with others, to drive up to the Catskill Mountains to interview a very young, and sometimes clueless, Pastor. When I subsequently came to the Wyckoff Reformed Church Fred became my champion. We had lengthily and very helpful conversations about the church and the congregation. Fred had amazing insights about the dynamics of good decision making.

Whenever I preached Fred and Betty were always present. For some 40 years they never missed the 6:00 a.m. Easter Sunday Sunrise Service which I led. In many ways Fred was my Pastor. His encouragement and enthusiasm for the Christian faith often kept me going.

Fred seldom gave me advice—but he did give me one piece of advice. He once told me to travel when I was young because I would not always be able to travel. My wife, Cyndie, and I have taken that advice seriously and have therefore had many enriching and memorable experiences we otherwise would have missed.

I thank God for the privilege of being a friend of Fred Michel.
