The History Club



t the October meeting of the History Club **Walt Widmer** presented a comprehensive overview of the Middle Ages, as it was comprehended by him, from the rule of Constantine in the 300 AD's to the fall of Constantinople to the Ottoman Turks in 1453.

Some salient points made by Walt included the following:

- 1. Constantine reunited the Roman empire by force and ruthless leadership.
- 2. He moved the capital from Rome to Constantinople formerly Byzantium.
- 3. By the Edict of Milan (313 A.D.) he ended the persecution of the Christians and officially recognized this religion. In fact, Constantine was, himself, converted to Christianity.

In addition, Walt discussed the fall of the Roman Empire in the west (476A.D.) by the barbarian, Germanic tribes that overwhelmed the empire - i.e. Goths, Visigoths, Vandals, Franks, Angles, Saxons, etc. The Huns, savage invaders from central Asia, led by Attila, ("the Scourge of God,") also greatly weakened Rome and hastened its downfall.

During this period, (7th and 8th century) the Arab tribes rapidly adopted the new Muslim religion as the carved out a great empire of thousands of miles - i.e. today's Middle East, Egypt, Iran, north Africa, and Spain. The Arab Muslims also invaded France, but were defeated by the now Christian Franks, led by Charles Martel, at the decisive Battle of Tours (732A.D.) near Paris. Walt pointed out that, if the Muslims won this battle, the religion of Western Europe could have been permanently altered.

One of the most important rulers in medieval Europe was the grandson of Charles Martel - namely, Charlemagne. Charlemagne increased the power of the Catholic Church by ending the barbarian threat to the Papal States and by converting pagan people to Catholicism. At Rome, in 800A.D., Pope Leo III, recognized Charlemagne's services to the Church and western Europe, by crowning him "Emperor of the Romans" - i.e. the Holy Roman Empire. (Most historians claim that the Empire wasn't much holy, not run by Romans, Germans would be more accurate, and certainly not a centralized Empire - more like independent feudal states.)

Although barely abled to read and write, Charlemagne valued education and . established schools in monasteries and cathedrals to instruct both the clergy and he common people. He also encouraged he collecting and copying of Latin manuscripts to preserve ancient learning. Some historians consider him the first "Renaissance" man.

Walt's remarks also concentrated on the influence of the Vikings in world history. Most of us associate this group with reckless conquering and mayhem, but Walt pointed out that they were great ship builders- i.e the vessels were sleek and fast moving - and that they engaged in voluminous trade with the ports all over Europe.

The Catholic Church was probably the strongest institution during the Middle Ages. Supreme in religious matters, it also undertook many non-religious functions that were beyond the power of the weak feudal governments. In the 13th century, the Church established the "Holy Inquisition" to uncover and try heretics - those Christians whose religious views the Church considered false and therefore dangerous. Persons suspected of heresy were tortured to secure confessions and repentence. Unrepentent heretics were handed over to the religious authorities for punishment - usually by being burned at the stake.

Also during the Middle Ages important religious orders were founded - templars being one of them. These orders continued the functions of monks and knights. They cared for the sick and injured, and they fought the Muslims to regain the Holy land.

The presentation was concluded by talking about the Black Death (1347-1350), a contagious and deadly bubonic plague, caused by flea bites, which killed almost one-third o western Europe's population.

The History Club meeting is Monday, November 25 at 1 PM- 3rd floor, WRC. Our speaker is **Fred Steinberg**, the topic of his presentation is "The Tuskegee Study of Untreated Syphilis in African-American male, 1932-1972." This was a very captivating study conducted by the Public Health Service. The study involved black men with syphilis and was conducted without the benefit of "patient's informed consent."

Computer Technology Club – October 16, 2019 Meeting

There were 30+ AU Members in attendance at the Wednesday, October 16, 2019 meeting of the Computer Technology Club. The meeting topics included a variety of items with the focus of the meeting being an update on the use of technology in the medical field.

Prior to our normal look at several technology-oriented videos and gadgets we watched a comedy oriented video on an Irish Funeral. The first was a look at a video on Norm Glasses ... this is a product that in essence has a smartphone built into the glasses. Next, we watched a very informative video on a product called DXO One ... this is an add-on product to the iPhone to enhance the capabilities of the iPhone's camera function. However, good the product appeared I was informed that the product is no longer on the market as the company filed bankruptcy. And, next we looked at a very informative video on Artificial Intelligence ... this video was to provide all with some basic knowledge of AI. The reason it was shown is that Bob Fern provided a series of articles from the WSJ on Artificial Intelligence ... these articles will be posted to the Reference Section of the computer page. Then we looked at several items included on the AU's website, new items added to the Computer Page Reference section and/or to the Helpful Tips section. We also, explored several other sections of the AU Website to let those in attendance know what is out on the AU Website. We are still looking at the suggestion made last month to organize the Reference Section alphabetically with a date presented ... what was agreed would be helpful is to setup the information on the Reference Section with a topic in alphabetic sequence with links to the relative information maintained on separate pages.

And, lastly we watched a video on Apple Product Repair this video could be applied to just about and technology products and how the manufacturer tries to push the consumer into a new product instead of repairing the old producer ... the video was very informative.

Next we looked at several uses of technology in the medical field. These items and / or links will be added to the reference section of the computer page on the AU Website. We looked at 10 ways technology is changing healthcare, 8 technology trends in healthcare to watch in 2019 and beyond, 6 best medical apps for doctors and last 50 healthcare apps for clinicians and consumers. Please review this information and we can discuss further at the next meeting.

The "Ask John" segment was covered by John Abrahamsen. John covered several items regarding bookmarking in Google Chrome and several items regarding the roster on the AU Website. Write-ups on these items will be posted to the website.

The Book Club

The Fifth Risk by Michael Lewis, summarized by Tom Butler, was the first book discussed during this session. It begins by describing the lackadaisical effort performed by the Trump transitional team in making new appointments in the new administration, compared to the smooth and complete transitions of the George W. Bush and Obama transitions. Not only were many positions slow in being filled, others were staffed by seemingly unqualified personnel, many of whom were uninformed about the functions of their new workplace and failed to use the briefing books prepared for them. Lewis tells of examples such as lack of funding in the Department of Agriculture leading to cuts in food stamp and school lunch programs and at the Department of Energy not sufficient inspectors to prevent black market uranium from falling into the hands of terrorists. The title of the book comes from the author's listing of five major risks to the U. S. – a domestic accident with nuclear weapons, North Korea, Iran, an attack on the national grid, and the fifth failures in project management. The second half of the book is more optimistic as Lewis focuses on a few dedicated long serving individuals in the bureaucracy who are instrumental in keeping it going. One criticism of the work was a complete absence of bibliography that would substantiate any of his claims.

Our second book was *The Pioneers*, written by the historian David McCullough. It focuses on those who set out to originally settle the Ohio Territory, the vast wilderness of what today is Ohio, Illinois, Indiana, Michigan and Wisconsin in the years between the American Revolution and the Civil War. It portrays Manasseh Cutler, an influential member of the Congress who secured support for the endeavor, and Ephraim Cutler, a general in the Revolutionary War who led the first party into the new territory as chief initiators of the migration. The author goes on to tell of the countless hardships faced by the settlers as they confronted the job of clearing thick tracks of forest with hand held axes and saws to grow crops, of unexpected harsh weather, starvation and violence between settlers and Indians and eventually establishing the cities of Marietta and Cincinnati. McCullough's access to a huge supply of original documents at the Legacy Library at Marietta College allowed him to compile a large and varied cast for his work.

Books for November:

The First Conspiracy (non-fiction) by Brad Meltzer and Josh Mensch

The story of spies and agents working for the Crown against George Washington and the Continental Army during the American Revolutionary War for political and monetary reasons.

The Vanishing American Adult (non-fiction) by Ben Sasse

Discusses the reasons that this generation can't grow up and offers a path for children to become active and engaged citizens. The author identifies core formative experiences that all young people should pursue and parents can encourage.

Books for December:

The Two Income Trap: why middle income mothers & fathers go broke (non-fiction) by Elizabeth Warren Written in 2003 Warren explains why the bankruptcy rate is increasing in the middle class.

The Fortunate Pilgrim by Mario Puzo

Puzo's personal favorite, the life of a southern Italian immigrant who settled in NYC in the 1920,s.
