Public Discussion Group

he Discussion Club met on Friday, Sept 16. Meeting on the third Friday seems to be working well as 31 members joined in a lively discussion. The members decided to take a new approach, namely to pick the topics at the start of the meeting to ensure timeless and relevance. The meeting started with an exchange on the topic of: "Should Congress hold the deficit ceiling and the budget hostage in order to thwart implementation of a law, such as Obamacare?" Members expressed a variety of views about whether the risks of the new health care policy warranted such extreme tactics. Most felt that Congress would not allow the US Govt. to default on its debt obligations, while some felt it was the only way to control the ballooning debt and avoid "socialized" medicine. Our second topic was "Should the US be intervening in the Middle East, especially Syria?" There was a lively exchange on the wisdom and effectiveness of US military involvement and the motives-humanitarian, economic and geopolitical. We debated whether "dictators" were preferable as a way to contain ethnic, clan and religious divides in the region. There was a broad consensus that recent military interventions had not succeeded and in fact had often worsened the situation. There was near unanimous agreement that the US should not get involved in Syria. Before adjourning, we briefly discussed a tropic that will certainly come up again. "Would you allow a child/grandchild to play football in the light of the evidence about potential brain damage?" The discussion had to be curtailed because of time, it was clearly a subject of interest with divided views about the benefits and risks of contact sports. The next meeting will take place on Oct 18 at the Larkin House at 9:30 am. All are welcome and we look forward to a good discussion

have now met twice with Ray Brown, Arthur Lane, and Ted Brandon to discuss and do some initial brainstorming about the need and potential of a group for retired men sponsored by Wyckoff Reformed Church. I stumbled onto this possibility for WRC some months ago when learning about a very caring men's group sponsored by the First Presbyterian Church of Ridgewood called Hobbyists Unlimited. When making a home visit one of our members told me, "I have lived in Wyckoff nearly all my life, but now that my wife has died it seems that the only people who remember me are people from Church and from Hobbyists. I subsequently learned that Hobbyists Unlimited has a membershfp of 350 and a, waiting list of 90. Ray, Arthur, Ted, and I have spent an afternoon with Russ Wollemann, President of the Ridgewood group, during which time we familiarized ourselves with the groups Constitution and Bylaws, Policies, Practices and Procedures, Organization, and Program. During our second meeting Ray, Arthur, and Ted declded that they would like to proceed as an Ad Hoc Committee with myself as Chariman planning a group for retired men sponsored by our Church. Before investing additional time and energy, we would appreciate receiving the Consistory's preliminary approval of this concept. Following the Consistory's preliminary approval, we would then like to return to the Consistory, one month from now, with a complete plan for the Consistorys cosideration and final approval.

TO ALL GARDEN CLUB MEMBERS

The September 2013 Garden Club meeting began with sharing observations on some of the current tomato growing season questions.

Do you prune sucker branch growth? Members present didn't bother to do this and did not observe adverse production from their plants. What about plants curling leaves? This condition is quite common, but it does not seem to harm production.

Rutgers is currently working on improving the quality and taste of new tomato varieties to be ready by the spring of 2015.

Jack Elwood showed us copies of a magazine he subscribes to which he highly recommends as a useful resource on horticultural topics.

Art Capello provided cards of a tree service that he had a very successful experience using.

Terry Gilley reported on a successful "critter" control system he uses for ground hogs.

Don Chucka did get some production from his grafted tomato trial this year, but he was not impressed with the overall result from this system.

Our group decided to hold on the previously proposed trip to Duke Gardens. Instead, we are working on another closer garden destination.

The often asked question at this time of year is, "when do you prune big leaf hydrangeas?" These shrubs should be pruned soon after they have flowered on the previous year's growth and before buds start to form on the current year's growth. Therefore, pruning should be done <u>in summer</u>, after blossoms have faded and before buds have formed.

Other shrubs, such as rose of Sharon, peegee hydrangeas and crape myrtle should be pruned in early spring. You need not be timid about early spring pruning for These types of shrubs benefit which benefit from this type of rejuvenation. Questions?
