The Hiking Club

The hiking club hikes most Mondays from September thru June, with extra hikes over the summer for enthusiasts. We carpool from WRC parking lot and leave at 9 am. Most hikes are about five miles and concentrate on the Ramapo Mtns and Harriman State Park trails. Hikes are on well marked trails and usually described as "easy or moderate." Hikers are in their 60's, 70's and yes, even 80's. So, if you are in good health and have hiking shoes and a light backpack, you would probably enjoy this activity and you're certainly most welcome to join in. We make sure the pace is one all participants can manage. The area we hike has some of the most beautiful forest scenery and views of the surrounding valleys and rivers. It's a time to enjoy nature and the fellowship of the trail. Some hikes go further afield and have included the Delaware Water Gap area and Lake Minnewaska. Below is a brief description of a hike we did in this month.

The "ORAK" trail. This hike was a little under 5 miles and listed as moderate in difficulty and took about 4 hours to complete. It's hard to describe the pleasure of walking in the quiet woods and hearing streams flowing, seeing hawks and occasionally a bald eagle soaring, and observing the different types of trees and bushes, including wild blueberries and raspberries that we munch on. Equally important is the sense of fellowship that comes from experiencing the hike as a group. Lunch on the trail (or sometimes afterwards at a nearby diner/restaurant) provides a chance to socialize and share stories. Highlights of this hike included the now desolate ORAK estate, built by the owner of the CARO Syrup Co. (ORAC is CARO backwards); a fire tower we were able to climb up and the stone shelter at the top of the trail. Pictures below illustrate these parts of the hike. Public Discussion Group

The group had two topics for its August meeting. We first took up the question of whether there should be a "citizenship question" on the 2020 census. The group seemed fairly evenly divided on this issue. Discussion revolved around the text of the Constitution, which makes reference only to "enumerating the number" but leaves how that is done to Congress. Historically, the decennial census has counted everyone resident in the US and its territories. Because of concerns about the integrity of voting, it was proposed that the 2020 census include a question about "citizenship." The issue in this regard was whether this question might result in an undercount of the total population, which in turn determines the number of Representatives apportioned to each state. The Appellate Court disallowed the inclusion of this question due to a lack of a proper rationale for including it. This citizenship issue led to abroad discussion of "immigration" and whether undocumented immigrants (estimated at 4%-6% of total population) were distorting the census count. There was some discussion as well of immigration from Mexico and Central America and the effect on jobs and public welfare services. It was a far ranging discussion with many members contributing.

The next topic looked at the question of "fake news." Most of the discussion grappled with defining the meaning of fake news. There was general consensus around the idea that the effect of social media and the ability to disseminate "information" by anyone to the enormous audience had gradually eroded the distinction between "facts" and "opinions." Compounding this effect is the natural effect of individuals gravitating to news sources that reinforce existing views. Overtimes, these views take on more credibility and result in a hardening of views and the emergence of "alternative facts." Both ends of the political spectrum seem to have fallen prey to treating opinions as fact. This behavior is not likely to change soon.

The group next meets on Wednesday, September 11th at 9: 30 at Larkin House. The topics will be: Health Care, "The Squad;" and Brexit-Good or Bad. All members are welcome.
